Council Composition

The Statute of the Orthodox Church in America, Article III, Section 2, states that the composition of the All American Council is composed of the following:

The Metropolitan and all bishops of the Church;

The priests of each parish and an equal number of lay delegates;

Priests not having parishes if accredited by the Metropolitan Council;

One lay delegate from each parish not having a priest;

The members and alternate members of the Metropolitan Council, and the members of the Auditing Committee of the Church;

Two delegates from each theological seminary;

Members of the Preconciliar Commission; (and)

One representative of each Church organization officially accredited by the Holy Synod;

Delegate/ Alternate Information

Article III, Section 6 of the Statute sets forth the following requirements for lay delegates and alternates to be validly elected, qualified, accredited. They must:

Be elected by a parish meeting;

Be a member of the parish in good standing (cf. Art. X, Section 5), at least eighteen years of age, having received the Sacraments of Confession and Communion at least annually for the past three years at his/her home parish. (Like holders of all offices in the Church, he/she may not be a person under ecclesiastical interdict, who is in violation of moral standards, who is married outside the Church, who is a member of anti-Church and/or secret societies.)

Be approved by the parish rector (or dean in the case of vacancy in the parish) to represent the parish.

Once an alternate has been authorized to be a delegate, his/her status is non-transferable.

Observer Information

The following rules apply to Council Observers:

Parishes may nominate any number of observers.

Observers must be parish members in good standing and must meet the same ecclesiastical and moral requirements that are applied to delegates.

Observers must be endorsed by the parish rector and confirmed by the diocesan bishop in order to be registered at the All-American Council.

Observers must submit payment for the registration fee of \$200.00. The fee includes registration, a banquet ticket, preparatory materials and Council documents.

Registration Forms

The Preconciliar Commission has distributed registration forms to each parish and institution of the Orthodox Church in America. These forms must be fully completed and returned to the OCA Chancery by June 15, 2005. In completing the enclosed forms, please carefully follow these steps:

The rector and/or parish council secretary complete the enclosed clergy, delegate, and observer registration form.

The rector and parish council secretary sign the form and affix the parish seal.

The delegate(s), alternate(s), and observer(s) read Statute Article III, Section 6 (listed above).

The delegate(s), alternate(s), and observer(s) sign the registration form.

The rector and/or parish treasurer attach a check to cover additional delegate(s) (if applicable) and any observers.

The registration form and check are to be mailed to the OCA Chancery no later than June 15, 2005.

The official schedule will be distributed to clergy, delegates, and observers upon registration.

Council

Assessments

The treasurer has distributed to parishes and institutions invoices for Council assessments. The Statute requires that each parish or institution must be in compliance with its 2004 financial obligations to the Church in order to have representation at the council.

Youth & Young Adult Activities

The theme for the Youth & Young Adult Activities at the Council is *Our Church and the Future: Become What You Are.* Activities will be available for the following age groups:

Ages 6 and under (Parent and Me daily two-hour session)

Ages 7- 9 Registration and Activities Fee \$200

Ages 10-12 Registration and Activities Fee \$200

Ages 13-17 Registration and Activities Fee \$200

Ages 18 + Young Adult Observer Fee \$200. Participants in this category must register as regular observers; for qualifications and requirements see the Observer section above.

Supervision

Youth observers are signed in once at the beginning of the day and then signed out at the conclusion of the day's activities according to the times noted on the youth activity schedule. There is no staff making sure that every youth is at every activity nor will the staff monitor youths' behavior when not signed into a scheduled youth activity. Parents and/or chaperones are responsible for youth at any time they are not signed into one of the Church's youth activities, including all evenings.

Travel Documents

Visitors to Canada must provide Canadian customs and immigration officials with proof of citizenship such as:

A valid passport, or

An original or certified copy of your birth certificate with a raised seal, PLUS photo identification.

For information on obtaining a U.S. passport, go to http://www.travel.state.gov/ or visit your local post office. Visas are not required for U.S. tourists entering Canada from the U.S. for stays up to 180 days. If you are a naturalized U.S. citizen and do not have a passport, you should travel with your naturalization certificate. A driver's license or Social Security card is not valid proof of citizenship.

If you are not a U.S. citizen but live and work in the U.S. and carry a valid foreign passport and Green card, you may enter Canada. For all other questions about entering Canada, we advise that you contact your country of origin's consulate. Mexican citizens entering Canada should also check all customs and immigration requirements that Canada and Mexico have with one another.

International Travel With Minors (including Canada & Mexico)

Due to international concern over child abduction, many governments have initiated additional requirements at arrival and departure points when children under 18 years old are not traveling with both parents. Many countries require documentary evidence of the adults' relationship and permission of the parent(s) or legal guardian before they will allow the child to cross the border. Single parents, grandparents, or guardians traveling with children often need proof of custody or notarized letters from the other parent authorizing travel. **These requirements are in addition to passport or proof of citizenship requirements.**

International Travel With Minors (including Canada & Mexico)

If a minor child is traveling with **only one parent**, the other parent must provide **notarized consent**. If **only one parent has legal custody**, that parent should be prepared to provide a court order of child custody to airlines and international authorities. If a minor child is **traveling alone** or in someone else's company, both parents (or the sole, documented custodial parent) must provide **notarized consent**. If a child traveling has a **different last name** from the mother and/or father, the parents should be prepared to provide evidence to airlines and official authorities, such as a birth certificate or adoption decree, to prove that they are the parents. If **one parent is deceased**, a death certificate is required. If the birth certificate shows that the minor **has only one parent**, it will be sufficient to hold only a **notarized copy** of the birth certificate.

GST Refund Information

Visitors to Canada (non-Canadian citizens) are entitled to a full or partial refund on any Canadian national sales tax (GST-Goods and Services Tax) paid while in Canada. Sheraton Centre Toronto staff will supply Council participants with refund forms. You must apply for a GST refund to obtain the refund.
