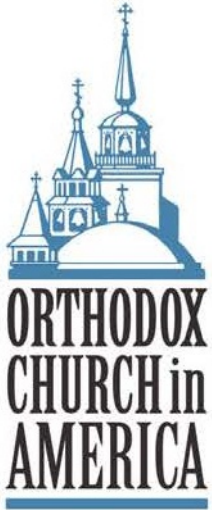
ASSIGNMENTS
